# Informational

Neighborhood Meeting for Conditional Rezoning and Special Use Permit: 313 N. State Street

A Special Use Permit and Conditional Rezoning Request has been received by Gemini Capital Management, LLC for 313 N State Street. The applicant is proposing to develop eight (8) residential units on the second floor, and to conditional allow one (1) apartment on the first floor of the building annex. The property is zoned B-1, Central Business District. The B-1 district does allow residential uses provided they are on the second or higher floors of a permitted use through the issuance of a Special Use Permit.

Per the conditional zoning ordinance, a conference is to be held prior to the public hearing by the applicant and the Zoning Administrator to discuss the proposed development. That meeting will be held on Wednesday January 2, 2019 at 7pm here at City Hall. 300' letters have also been sent to area property owners. Staff would appreciate representation from the commission at this meeting. We believe it would be beneficial for you to have an opportunity to be involved in this process from the beginning. Please make sure we coordinate the effort so as not to create a situation where we have a quorum of the commission. This has not been noticed as a public meeting.

The public hearing has been set and noticed for Monday January 7, 2019 at 7pm here at City Hall.

• Neighborhood Meeting for Rezoning: 211 Woodworth

A request to rezone the parcel of land located at 211 Woodworth Avenue, from B2, General Business to LI, Limited Industrial has been received from the owners Joseph and Dawn Ahern. The parcel to the east is zoned LI, Limited Industrial allowing the property owner to request this zoning designation for leasing the property as a medical marihuana grow facility.

A conference has been scheduled to meet with the applicant and Zoning Administrator here at City Hall on Thursday January 3, 2019 at 7pm. Unlike the conditional zoning application, this request does not require a preconference. However, staff feels that it would be beneficial to engage the same discussion prior to any proposed change in zoning. Again, we believe it would be good to have commission representation at this conference as well, keeping in mind this is not a noticed public meeting.

Conditional Rezoning Agreement for 601 Woodworth/119 Hastings

Attached is a copy of the Conditional Re-Zoning Agreement between the City of Alma and Ivory Manor LLC for the property located at 601 Woodworth and 119 Hastings. On December 3<sup>rd</sup> the Planning Commission, after a public hearing, recommended approval of the conditional rezoning with conditions. The agreement will be brought to the City Commission for consideration at the first meeting in January.

#### Commissioner Handbook

Attached is a draft of a handbook I have created for commissioners. The handbook is intended to describe select guidelines by which the Alma City Commission operates. The handbook includes excerpts from the City Charter and Code of Ordinances. The handbook could serve as a quick reference guide for new and experienced commissioners and staff. Please take a look at the draft and give me any input. Commissioner Allman asked that the City Charter description on Commissioner's monetary compensation should be added.

# • Goal Setting 2019: January 23, 2019

In December of 2017 I asked City Administrative Staff, Supervisors, and Commissioners to address their issues and concerns for the City of Alma's future through a goal setting packet. We also looked at the organization, its effectiveness, and then attempted to identify goals for the upcoming year. This data was compiled and then presented at the Goal Setting Session in January. At that time the data was discussed in a public meeting, and 4 themes were developed: Organizational Effectiveness/Employee Development, Community Engagement, Development and Infrastructure, and Funding/Finance. The information is still pertinent. I have compiled a list of the topics we discussed and emailed them out to supervisory staff and the commission for input.

Eventually we came up with 2 seemingly simple goals for the year, #1 Fix the organization, and #2 repair our reputation with the community. I can tell you that we have worked hard on those goals throughout the past year. Many of our accomplishments involve making major strides forward with our staff and the community. We should be proud as an organization of our successes in the past year.

I have also asked for accomplishments and goals for discussion at the January 23<sup>rd</sup> Goal Setting Session. If for some reason you did not receive the packet, let me know and I will get it out to you.

#### • Fireworks Legislation

It appears Michigan municipalities could restrict the use of fireworks on more days under a bill that was nearing final legislative approval upon my writing on Friday.

Under current law, consumer-grade fireworks can be shot off 30 days of the year, which surround holidays. Under the new bill, the 30 days would stay, but communities could limit that number to 12 days, mostly around the Fourth of July. Communities could pass ordinances that limit fireworks to just those days or allow fireworks on all the 30 days.

And while the current fireworks law generally allows fireworks to be set off until 1 a.m., the new bill says that communities could pass ordinances that cut off fireworks after 11:30 p.m. on some days.

A presentation was given by Police Chief Kendra Overla to Officers Alex Hawkins and Officer Robert Stack. Section 5.7.3 of the Alma Police Department Policy states:

The Medal of Honor is awarded to a member for an extraordinary act of heroism that goes above and beyond the normal call of duty and is carried out at great risk to personal safety in an effort to protect persons or property.

Today, I have the privilege to share with you all a portion of a shift worked by two of our police officers. On July 12, 2018 Officer Stack and Hawkins were on duty and had been working traffic when they were dispatched to the scene of structure fire at 1575 Pine Ave. Officers arrived on scene and without hesitation they made entry, ensuring that the residents of the building were evacuated.

Officers attempted entry into apartment 119 where the fire was so intense they were not able to gain access. Alma Fire Department arrived a short time later; with the scene ultimately being turned over to the Michigan State Police Fire Investigation Unit. Through investigation it was learned that one fatality had occurred I can only imagine that without the expedient response from Officers

Stack and Hawkins this number may have been higher.

When I arrived on scene I noted that the officers made sure that residents were out of harms way, remained calm and communicated with Fire Personnel. I watched as they resumed their duties; Officer Stack and Officer Hawkins responded to a suicidal subject, changed a patrol car tire and then checked on a suspicious vehicle all prior to getting checked out. You see both officers acted selflessly, they continued to care for others even though they felt the effects of the smoke they had taken in during the initial call. It is without hesitation and with great pride that I present both Officer Stack and Officer Hawkins with the Medal of Honor, a uniform pin and certificate of appreciation.

He also expressed his thanks to officer Hawkins and Stack for their act of heroism. 2018 was a roller coaster year for the City and he wants to thank Staff for all they have done in making it great.

Mayor Mapes wanted to echo the comments made for the Officers. He wanted to thank them for doing a great job. Do appreciate their service. Don it has been great working with you, you brought a valuable prospective. Mel,

I appreciate your guidance. You were a great mentor to me. I will miss working with you both. Thanks, on behalf of the Community for your service. Looking forward in seeing you in different roles.
